TREASURER'S REPORT - TARA OLSEN

- New MRSC Accounting Contact
 - Larkin Hubrig has left MRSC; Sandra Vong is accounting contact for now
- Quarterly Treasures Report (see attached report)
 - Where our chapter stands compared to the approved 2020/2021 budget
 - \$16,736 in revenue from investments (Pittis Scholarship Blackrock Fund)
 - Is there a tax obligation with this revenue? Olsen to check
 - (\$25,614) from refunds on CM workshop
 - Total YTD (\$61,923)
 - Talking to consultants re: projections for next six months
 - Implications for the future
 - With current projection of rev/exp (\$77,213)
 - Budget projected (\$70,000)
 - PWI & CM trainings could generate almost \$30,000 in rev
 - Huling/Behm to talk to Toby Rickman / John O. to discuss holding NWPWI virtually
 - Worley to talk to Sam Yaghmi to hold Construction Inspection virtually

- Committee summit action items update

 - Olsen wants to talk about committees doing virtual activities and workshops – use this topic for the working sessions

RESIDENTS REPORT - DONALD HULING

- Scammers Continue
 - o Be aware and do not buy gift cards or send money to anyone
- Second Term as Chapter President
 - Mr. Huling thanks the board for everyone's devotion to the chapter and wiliness to serve an additional year.
 - 2021 will be focused on reuniting our chapter in a safe manor
 - 2021's theme will be the appropriately named the "Reunion Tour"
 - The fate of the spring conference in Tacoma is still TBD
 - Virtual/In person options are still being considered
 - Final decision with respect to in person component to be decided mid-February (contingent on COVID 19 developments).
 - Currently under contract with the Tacoma convention center but not a hotel.
 - With the speed of vaccine rollouts, don't see in-person conference happening in Spring
 - Board needs to make a decision by end of Feb. will be before any governor's proclamation

- o Board in agreement with no in-person conference
- Donald will complete letter for Convention Center
- O What do we want to do with Spring?
 - Predict registrations and sponsorships would be lower than fall
 - May result in further loss in revenue
 - Do a smaller version
 - No CEUs
 - Legislative update & networking
 - Do nothing option

Discussion:

- Lugo one of the costs is sitting in on recorded sessions
 could transition to zoom and a volunteer
- Olsen: costs: small conf = \$10,000; full virtual conf = \$25,000
- Williams: want to do a little something, but don't want to wear out our sponsors
 - Would lower the levels of sponsorships
 - These sponsorships would be used across the virtual platforms
- De Boldt likes the idea of the small conference
 - People like the legislative update
 - Recognition of the project of the year awards
 - Donald already working on this video
- Haney says they are seeing zoom fatigue which may result in lower registration / sponsorships
- Phan: likes the smaller event for spring
 - WSDOT update on budget as well?
- Want to consider an outside networking event for summer?
 - Olsen supports the idea
- Fall conference in Yakima assumed to be in person at this point

- Assume bi-monthly conference calls at first
- Goal is to develop an implement chapter protocols for safe return to in-person chapter events

- Fall 2020 Conference debrief
 - o Conference committee held a debrief December 3rd, 2020
 - Fall Conference debrief summary document sent to the board
 - Highlights
 - 233 Attendees (178 members/ 55 non-members)
 - o \$26,825 registrations
 - 48 Exhibitors
 - \$3,500 virtual exhibitor booths
 - 21 Sponsors
 - o \$23,650 in sponsorships
 - Scholarship Donations
 - o \$1.460
 - Net Chapter Income
 - o **\$20,346.50**

COVID 19 Vaccine Advocacy

- Jim Rioux was proactive and penned a letter to Govern Jay Inslee advocating for front line public works individuals to be considered for prioritization with respect to vaccination order.
- As chapter president, Donald signed the letter and sent a copy to Governor Inslee, the Governor's chief of staff, and the Washington State Secretary of Health. This letter was sent out on December 18th, 2020.

MRSC 2021 Contract

- Tara Olsen and Donald Huling worked to revise the 2021 contract based on services needed.
- Reductions in MRSC services were primarily associated with the chapter magazine.
- Original contract was lump sum of \$2,200 per month. Revised contract is lump sum of \$1,945 per month.
 - Saving \$3000 per year by making magazine management a volunteer activity
- The Contract has been reviewed by APWA National and executed for a 1-year term.



• 2021 APWA Jennings Randolph International Fellowship Award

- The international affairs committee has selected John Milne, of Clark County, as one of two fellowship award winners this year.
- The award does not cover the full cost of the Fellow's international public works study tour. The committee has asked if our chapter would provide some level of financial support.
 - Mr. Huling has responded with an indication that chapter support would be discussed at this board meeting. Mr. Huling's response also indicated that chapter finances are tight due to COVID 19 and our ability to provide financial support was not guaranteed.
 - Olsen: Does anyone know John Milne?
 - What was the rationale for the last decision: "why isn't national paying for it?" it has not been where we have focused our scholarship dollars
 - De Boldt: there is a history of people participating at National that don't participate at the chapter level
- Chapter is going to submit Top 10 Award for Kathleen Davis
 - Behm to work with LILT
 - Need a letter from the Chapter as well
 - Need 6 recommendation letters: send template

 - The Value Initiative Team completed an environmental scan to find what definitions public agencies, APWA National, and other APWA Chapters are using to describe public works. What we found from this research was that the existing definitions of public works are not interesting or inspiring, and do not convey the "value to our quality of life." With that, the team decided that a tagline supported by imagery would be a more effective way to tell our story.

Working collaboratively with the Marketing Committee, we want to select a tagline, finalize designs, and present our ideas to the Board. After Board approval, we would like to continue to work with the Marketing Committee determine the best ways to implement and distribute our new PR campaign.
