 Removal and replacement of sidewalks, driveways, and curb ramps

- Utility relocations
- HMA paving and striping
- Signal and lighting poles
 - Water, Storm drain

Examples of Typical Long-Lead Items



Element	Procurement time
Signal poles and controllers	9 months - 1 year
Decorative lighting	9 months - 1 year
Traffic cameras	6 months - 1 year
Precast concrete	3 - 6 months



Methods for Mitigating Long-Lead Times

- Preorder materials
- Initiate contract procurement time and suspend
- Complete other project work and suspend





Preorder Materials

- Process
 - Order materials and procure materials prior to advertising the contract



Preorder Materials Advantages

- Material is available to be installed at Contractor convenience.
- Agency preferred items can be installed without approving an "Approved Equal".





Preorder Materials

Advantages

- Material is available to be installed at Contractor convenience.
- Agency preferred items can be installed without approving an "Approved Equal".

Risks


- Some grants/agencies won't reimburse for the preordering of materials
- Agency owns handling and condition of materials
- Material Storage



Initiate Contract Procurement

Time and Suspend


- Process
 - 1) Issue NTP to the Contractor
 - 2) Review and approve materials for procurement
 - 3) Suspend contract upon receipt of paid invoice



Initiate Contract Procurement

Time and Suspend Advantages

- Grant and Federal allowable
- All contract work completed at the same time
- Shorten project duration



Initiate Contract Procurement Time and Suspend

Advantages

- Grant and Federal allowable
- All contract work completed at the same time
- Shorten project duration

Risks

- Project can push to following season
- Delay in completion of other improvements
- Compounds schedule risk



Complete Other Project Work and Suspend

Process

- 1) Issue NTP to the Contractor
- Review and approve materials for procurement
- 3) Complete all available work
- Suspend contract until materials are received






Complete Other Project Work

Advantages

- Grant and Federal allowable
- Take advantage of Construction season
- Earliest project completion

Advantages

- Grant and Federal allowable
- Take advantage of construction season
- Earliest project completion

Risks

- Construction sitting out there 90% complete
- Construction Fatigue
- On going maintenance




Identify Public Coordination Needs During

- Precon Commitments List Review
- Walk and Knocks
- First Weekly Meeting





Walk and Knocks (businesses / residents)

- Hours of operation
- Delivery days
- Special events
- Services interruptions / connections





Walk and Knocks (businesses / residents)

- Garbage Days
 - Outreach to the servicer even if the road is open
- Bus Routes
- Mail Delivery
- Education on ADA and how that can effect their driveway




